Any use of logo and name of NCOF/NCONF, Ghaziabad is not only unauthorized but also unlawful. It is also notified that NCONF / NCOF and/or any of its RCONFs/RCOFs/Officers, does not in any manner whatsoever, attempts to either directly/indirectly solicit and/or persuade any person for waste decomposer through use of his/her personal mobile numbers. All communications to NCONF and/or its Officers are strictly done only through official channels/telephone numbers and under the email ID ending with the domain name nbdc@nic.in. Public at large is cautioned against any transactions with any such third party/agency and also on placing of reliance on any such online videos, advertisement, allegedly using the Govt. logo and name of NCOF/NCONF Waste Decomposer. For any act done, payments made, losses suffered by any person on account of such fraudulent activities of the said third party/agency shall be its sole responsibility and neither NCONF nor any of its Officers shall be responsible for any such acts. It be noted that all information is disseminated by NCONF only through its website "<https://ncof.dacnet.nic.in/>". Further all such third party/agency are called upon to immediately desist from misrepresenting itself to be authorized and/or related to NCOF/NCONF in any manner whatsoever and to stop using the name and logo of NCOF/NCONF without due Authority of Law. If found continuing, NCONF shall take both criminal and civil actions against such third party/agency without any further notice. The public in general and other agencies in particular are again cautioned and advised to avoid dealing with any such third party/agency claiming NCOF/NCONF waste decomposer.
